**ELECTION DAY**

For the Saturday, May 8, 2010 Election, registered voters living within the jurisdiction of the Lake Travis Community Library District must vote at designated Voting Locations. Voters should refer to their Travis County Voter Registration Card to verify the Precinct in which they reside, and vote at the Voting Location, as indicated below, that includes their Travis County Precinct.

**EARLY VOTING**

Early voting by personal appearance will be conducted each weekday at locations designated by the Elections Division of the Travis County Clerk between the hours of 7:00 a.m. and 7:00 p.m. beginning on Monday, April 26, and ending on Tuesday, May 4, 2010.

Registered voters living within the jurisdiction of the Lake Travis Community Library District may vote at any Early Voting Location on the dates and times set forth by this Order.

For the purpose of Early Voting, the judges will be as designated by Travis County.
